

**Season permits – Condition of Issue – All fisheries 2020 onwards**

1. The holder shall be responsible for and release and indemnify of Canal & River Trust, their servants or agents, from and against all liability for personal injury (whether fatal or otherwise) loss of or damage to property or any other loss, damage, costs and expenses which may arise during or in consequence of the exercise of the permission granted. Permit holders are advised to take out individual insurance covering their third-party risks arising out of their angling activities.
2. In exercising the permission granted, the holder undertakes to comply with Canal & River Trust by-laws or any specific rules or regulations which may from time to time apply. In particular anglers must ensure that they possess an Environment Agency rod licence and that all angling is carried out in accordance with the individual fishery rules and any by-law requirements.
3. The holder will not by any act or neglect cause injury to any person or damage to any property and will use his or her best endeavours to keep clear of any craft or dangers whatever the nature.
4. The permit is not transferable, and it may be withdrawn by, and must be surrendered to the issuing office at any time on demand. If the permit is withdrawn at any time before a period of not less than four weeks from the date of expiry (other than for a breach of the conditions of issue) a proportion of the charge will be repaid if claimed.
5. Only the person named on the permit is permitted to fish.
6. The permit is valid for daytime pleasure fishing only, unless specifically stated otherwise.
7. The permit is only valid at the fishery it is issued for.
8. Fishing is on a first come first served basis. There may be occasions when there is limited peg availability or no pegs available.
9. Individual fishery rules apply. Please make sure you are aware of these rules before commencing fishing.
10. Permits should always be carried when fishing and must be made available for inspection by authorised members of Canal & River Trust staff or an appointed agent or fishery bailiff.
11. Fishing shall be carried out with a maximum of two rods, unless stated to the contrary on the front of this permit.
12. Not more than six fish to be taken and used as live bait in any one day. These are to be used only on the permitted waters. No live baits are to be brought onto site or removed from the fishery.
13. To help stop the risk and spread of disease, all nets must be completely dry before fishing. Please take your nets to the bailiff in the club house to verify that they are dry before moving to a peg.
14. All fish caught must be returned to the water from which they were caught.

## **Naseby Reservoir fishery – season permit rules from 2020 onwards**

1. Night fishing is permitted, but anglers must book in advance.
2. No fires other than cooking stoves.
3. No litter of any description to be left on the fishery.
4. Radios, portable stereos or similar equipment can be used on site provided they do not create a disturbance to other anglers or the general public.
5. No dogs are permitted whilst fishing.
6. No 'constant lights' are permitted. However, the use of a head torch or pocket torch is permitted.
7. Fishing equipment should not obstruct public footpaths.
8. Anglers must fish the swim immediately in front of them and not space rods so as to spoil the sport of other customers.
9. No keepnets permitted.
10. Unhooking mats must be used at all times and all fish to be returned to the water except for those to be used for livebaits. Those which are unused should also be returned. It is an offence under the 1968 Theft Act to remove fish from the site.
11. The use of heavy fixed bolt rigs is not permitted.
12. The pike season for live baiting and dead baiting will run from 1 October to 31 March. Live baits must be caught from the actual reservoir in which the customer is fishing and must under no circumstances be brought in from another water.
13. The use of bait boats is not permitted. Fishing markers must be removed from the water after the fishing session.
14. Permits are not transferable and must be carried at all times whilst fishing. It is an offence under the Theft Act to fish without permission of the owner.
15. Season permit holders will be responsible for the stewarding of other season permit holders between sunset and sunrise. Each season permit holder has full right and authority to check the credentials. In the first instance any issues such as fish theft, illegal methods of fishing or pollution should be reported to the Environment Agency on their 24-hour emergency number 0800 807060, and thereafter during normal working hours to the fisheries bailiff by phone on 07904 493417.
16. Naseby AC bailiffs, Canal and River Trust employees and the police, on proof of identity, are also entitled to check permits at any time.

17. All cars are parked at the owner's risk and parking should not take place on public highways or verges.
18. Canal and River Trust give no guarantee as to water levels in the reservoir.
19. In the event of an angler not adhering to the fishery rules, Canal and River Trust and Naseby AC retain the right to withdraw the permit without recourse to a refund and for that person to be excluded from fishing at any Trust fisheries.
20. Canal and River Trust and Naseby AC reserve the right to close part or all of the reservoir to anglers. Except in an emergency, details of any such closures will be posted on the fishery notice boards.
21. When night fishing, in the event that a match is booked on the peg that you are occupying, then fishing must cease at 6am on the day of the match and you should be packed away and leaving the site by 6.30am or thereabouts.
22. Guest tickets are available to season permit holders only at a cost of £20 per 24-hour period. These can be purchased in advance from the head bailiff. Details of the guest name and the sponsoring member's card number must be supplied.
23. All persons night fishing are required to have self-contained toilet facilities.
24. Bivvies and other equipment should not be left unoccupied for more than 4 hours. Any equipment left unoccupied is entirely at the owner's risk.
25. No junior anglers may fish at night unless accompanied by an adult season permit holder.
