IT IS ORDERED that:-


1. All further proceedings as between the Claimant and the Defendant in this action be stayed except for the purposes of carrying such terms into effect.


SCHEDULE

1. The Defendant shall pay to the Claimant the sum of £5,000 on or before 8 June 2012.
2. The Defendant shall pay to the Claimant, by way of direct debit, the sum of £2,000.00 per calendar month, such payment to be made on or before the 1st day of each calendar month, the first payment being due on 1 July 2012 with the last payment of £2,000 being payable on 1 December 2012.
3. The Defendant shall pay to the Claimant the sum of £1,767.63 on or before 1 January 2013.
4. The payments set out in paragraphs 1, 2 and 3 above shall firstly be allocated towards the cost of a current licence and mooring permit for the vessel "Victory", Index Number: 66489 for the period 1 November 2011 to 31 October 2012, in the sums of £832.01 and £7,458.30 respectively and, thereafter, to the cost of the Defendant's licence and mooring fee arrears and the sum owed to the Claimant pursuant to a Combined Certificate of Judgment in the total sum of £10,477.32.
5. Any amendment to this Order shall be made in writing and signed by both parties.
6. In the event of the Defendant's default in making the payments detailed at paragraphs 1, 2 and 3 above, this agreement shall lapse and the Claimant will be entitled to apply to the Court without notice for:
  - (a) judgment against the Defendant for licence fee arrears and monies remaining due under paragraphs 1, 2 and 3 above, (having given credit for any sums already paid by the Defendant in accordance with this schedule) together with interest calculated at the rate of 8% per annum and costs;
  - (b) an Order requiring the Defendant to remove the vessel "Victory", Index Number: 66489, from the canals and inland waterways owned or managed by the Claimant within 14 days of the date of such Order;
  - (c) an Order entitling the Claimant to remove the Defendant's vessel "Victory", Index Number: 66489 from the canals and inland waterways owned or managed by the Claimant pursuant to its statutory powers under section 8 of the British Waterways Act 1983 and section 13 of the British Waterways Act 1971;
  - (d) an injunction preventing the Defendant (whether by herself or by instructing or encouraging any other person) without the prior consent of the Claimant:
    - (1) from mooring or securing the vessel "Victory", Index Number: 66489 on or to any part of the Regents Canal; and


- (2) from entering, navigating or mooring the vessel "Victory", Index Number: 66489 from the canals and inland waterways owned or managed by the Claimant;
- (e) The Defendant do pay the Claimant the cost of these proceedings.
