

53342 from the canals and inland waterways under the Claimant's control pursuant to its statutory powers under section 8 of the British Waterways Act 1983 and section 13 of the British Waterways Act 1971.

2. The First, Second and Third Defendants each be forbidden, after 4pm on 17 February 2014, or within 14 days of service of this order on the Defendants if later, (whether by themselves or by instructing or encouraging any other person) without the prior consent of the Claimant:
 - (1) from navigating, mooring and/or securing the boat "Frieya", index number: 53342 on or to any part of the Grand Union Canal;
 - (2) from navigating, mooring and/or securing the boat "Frieya", index number: 53342 on any part of any of the canals and inland waterways controlled by the Claimant shown coloured blue on the plan and listed in the Schedule, both annexed hereto.
3. The First, Second and Third Defendants each do, by 4pm on 17 February 2014, or within 14 days of service of this order on the Defendants if later, remove the boat "Frieya", index number: 53342 from the property controlled by the Claimant.
4. Service of this order on the Defendants may be effected by placing a copy of this order in a sealed envelope addressed to the Defendants and attached to the boat "Frieya", index number: 53342.
5. The First and Second Defendants do pay jointly and severally the Claimant's costs in respect of this action, summarily assessed in the sum of £1,039.00, payable within 14 days of the date of this order.

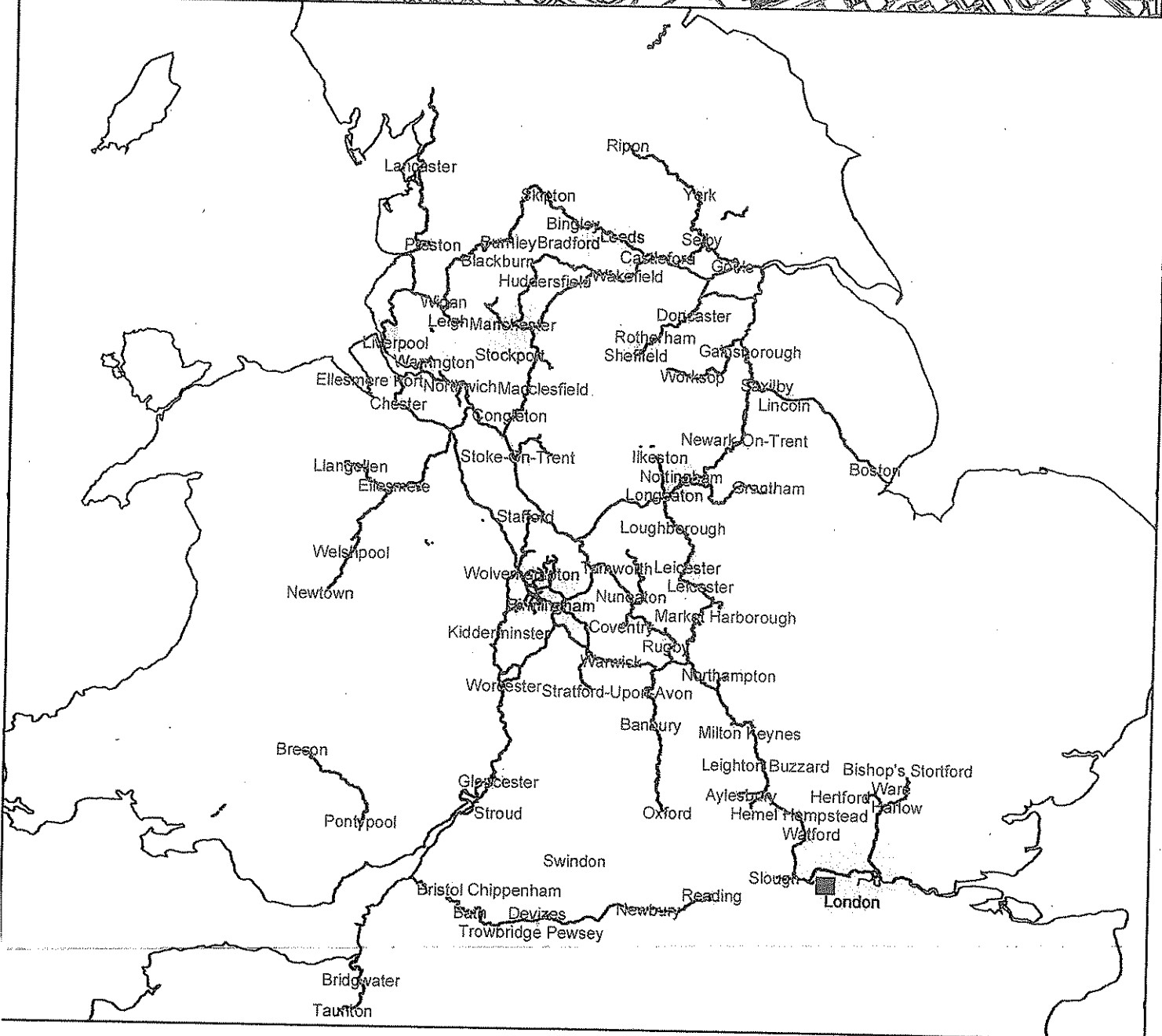
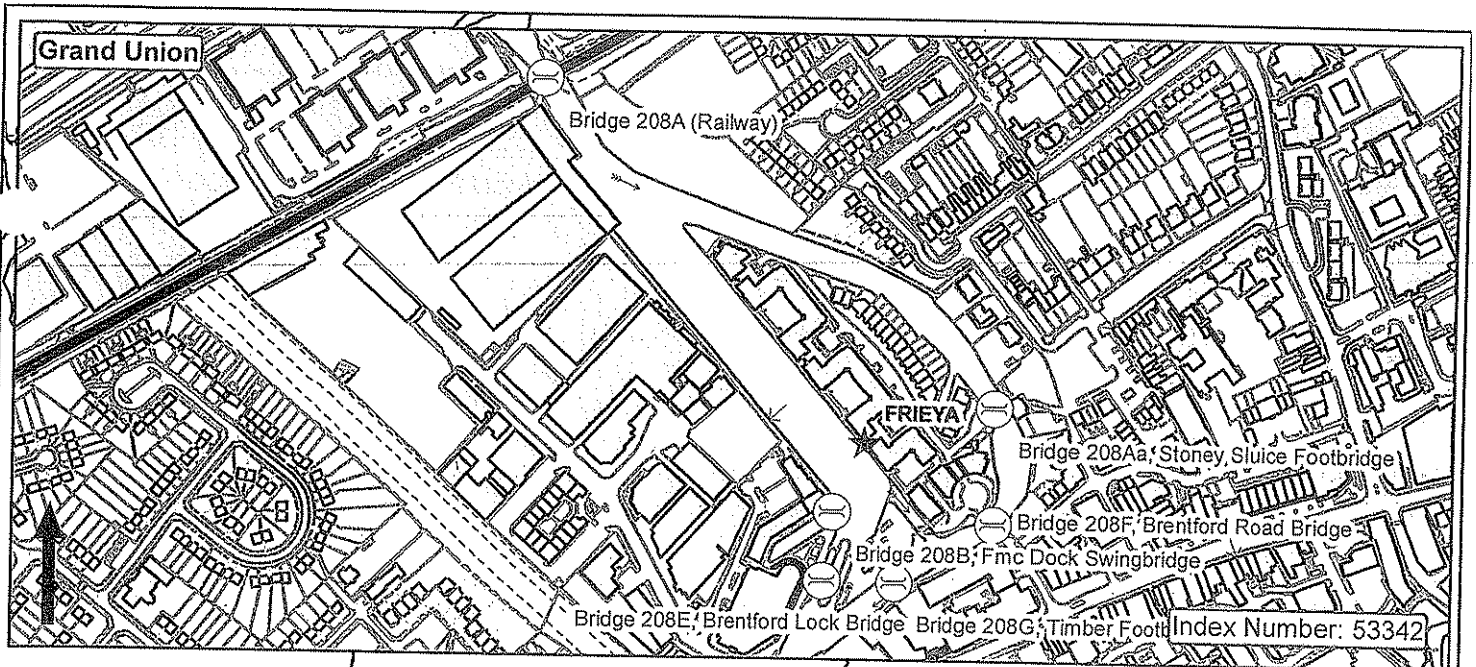
