7. Angling Strategy

Becca gave presentation on Development of Angling & Fisheries Action Plan for the North East (see attached presentation) and the Angling Club Research findings.

Now have national plan but need to look at the local level, angling clubs, other partners etc. Looking at NE for pilot then roll out nationally. Stage 1 November, Stage 2 January, Stage 3 end financial year.

SH & BD working to see how then can work together. JT asked how Enterprise can work with them.
