## Order Amended under Slip Rule

UPON hearing the Claimant's Part 8 Claim

AND UPON hearing the Solicitor for the Claimant and the Defendant not attending

IT IS ORDERED THAT:

1. It is hereby declared that the Claimant is entitled, after 4pm on 23 October 2017, to remove the Defendant's boat "Karma Barosan" Index no 118097 from the canals and inland waterways under the Claimant's control shown coloured blue on the plan and listed in the Schedule, both annexed hereto, pursuant to its statutory powers under section 8 of the British Waterways Act 1983 and section 13 of the British Waterways Act 1971.

2. The Defendant is forbidden, after 4pm on 23 October 2017 (whether by himself or by instructing or encouraging any other person) without a relevant consent being issued by the Claimant:

(a) From navigating, mooring and/or securing the boat "Karma Barosan" Index no 118097 on or to any part of the River Lee Navigation; and

(b) From navigating, mooring and/or securing the boat "Karma Barosan" Index no 118097 on any part of any of the canals and inland waterways controlled by the Claimant as defined at paragraph 1 above.

3. The Defendant shall, by no later than 4pm on 23 October 2017, remove the boat "Karma Barosan" Index no 118097 from the property controlled by the Claimant as defined at paragraph 1 above.
