IT IS ORDERED THAT :

1. It is declared that the Claimant is entitled, after 4pm on 13 November 2018, to remove the Defendant's boat "Maryjane & Charlie", index number: 77730 ("the Boat") from the canals and inland waterways under the Claimant's control shown coloured blue on the plan and listed in the Schedule, both annexed hereto, ("the Claimant's Property") pursuant to its statutory powers under section 8 of the British Waterways Act 1983 and section 13 of the British Waterways Act 1971 unless on or before that date the Defendant has obtained the appropriate licence or consent from the Claimant for the Boat to make use of the Property.
2. The Defendant is forbidden, after 4pm on 13 November 2018, (whether by himself or by instructing or encouraging any other person) without a licence first being issued for the Boat by the Claimant, or otherwise with the consent of the Claimant:
 - (a) From navigating, mooring and/or securing the Boat on or to any part of the [REDACTED] and
 - (b) From navigating, mooring and/or securing the Boat on or to any part of any of the Claimant's Property.
3. The Defendant shall pay the Claimant's costs in respect of this action, summarily assessed in the sum of £1588.70 payable by £30 per month, 1st payment on or before 30 September 2018.
