Any not-for-profit organisation including:

- Community/voluntary groups
- Registered charities
- Community Interest Companies
- Charitable Incorporated Organisations
- Local authorities
- Schools and educational institutions
- Private owners of physical heritage (up to £100,000 – where public benefit outweighs any private gain)

Environmental Sustainability

Mandatory Requirement



- Minimise waste and single use plastics, use recyclable and biodegradable materials
- Tell people how to get to your site or events by public transport
- Take steps to increase biodiversity e.g. bird and bat boxes and green roofs
- Reduce energy and water use
- Tell people about environmental measures you have implemented
- Join the 'Fit for the Future' Network





£3,000 - £10,000

- Decision in 8 weeks
- No match funding
- No deadlines
- Up to 12 months





£10,000 - £250,000

- Decision in 8 weeks
- No minimum match funding for £10,000-£100,000
- 5% match funding for grants of £100,000 £250,000
- No deadlines
- Projects last up to 5 years
- Project enquiry service





£250,000 - £5million

- Mandatory Expression of Interest
- Two-stage application process
- 3-month assessment for each stage
- Quarterly deadlines
- Minimum 5% match for grants <£1million
- Minimum 10% match £1million upwards





Heritage Enterprise

£250,000 - £5million

- Not-for-profit and for-profit organisations
- At risk, designated historic buildings
- Commercial uses and housing
- Conservation deficit
- Two-stage application process
- Minimum 5% match for grants <£1million
- Minimum 10% match £1million upwards
- Quarterly deadlines and decisions
- Mandatory Expression of Interest


