

## Wish You Were Here – On The Water Photograph Competition Terms and Conditions

1. The competition is open to all UK residents aged 18 or over, except employees of the Promoter, their families, agents, volunteers working for the Promoter, or any third party directly associated with the administration of the competition.
2. The competition is free to enter, and there is no purchase necessary.
3. All entries must be submitted via the wish you were here web page on the Canal & River Trust website, and include the completed information requested.
4. There is no limit to the number of photographs that can be submitted, however it will be at the Promoter's discretion which photographs are published on the webpage.
5. The opening date for entries is 09:00 on 2 June 2022. The closing date for the competition is 23:55 on 31 July 2022. Entries received after this time will not be valid.
6. The promoter accepts no responsibility for entries not successfully completed due to a technical fault.
7. The subject for the photographs is of boaters with family and/or friends boating on the Canal & River Trust waterways. The aim of the photography competition is to focus on the love of going boating.
8. Images should be current and not historic or have been previously published elsewhere for commercial purposes.
9. If your image includes clearly recognisable individuals, we ask that you ensure permission from the individuals involved, for use of the image.
10. Images submitted into this competition may be used in promotions, advertising and for educational purposes, by the Promoter. All other rights remain with the photographer. Even if you do not win the photography competition, by entering into the competition you give the Promoter permission, for an unlimited period, to use the photographs you enter, for promotions, advertising and educational purposes. You give us this permission without us having to make any payment to you for such use. We acknowledge that you will remain the owner of the copyright in the photographs.
11. The Promoter will remove any photographs that do not meet the entry criteria or are deemed inappropriate.
12. The Promoter will display selected photographs entered on the Trust's website. Winners will be announced on our website.
13. One winner will be chosen at random each week in the period 2 June 2022 – 31 July 2022, from entries received during the week prior.

14. The winners will receive a choice of one on the Canal & River Trust t-shirts.
15. Winners of the competition will be chosen in accordance with point 13 above and verified by the Promoter.

17. The Promoter must either publish or make available information that indicates that a valid award took place. To comply with this obligation, the Promoter will announce the name and county of major prize winners as set out in point 12 above. In such circumstances, the Promoter must still provide the information to the Advertising Standards Authority on request.
